**SUBJECT: COMPLETION OF ACTIONS REQUIRED BY NRC CONFIRMATORY ORDER  
DATED OCTOBER 28, 2014**

Dear Mr. Kruger:

The purpose of this letter is to acknowledge that Kruger Technologies, Inc., has completed the actions required by the Confirmatory Order (Order) (ADAMS Accession No. ML14302A577) issued by the U.S. Nuclear Regulatory Commission (NRC) on October 28, 2014. The Order was issued in response to a settlement agreement reached during a September 3, 2014, Alternative Dispute Resolution (ADR) mediation session between Kruger Technologies, Inc., and the NRC.

The Order required Kruger Technologies, Inc., to take a number of actions including: (1) review and revise the company-wide policy to describe implementation of NRC safety and security requirements for portable gauges; (2) conduct training for all authorized users on the revised company-wide policy; (3) revise the company-wide training program; (4) establish a process to periodically conduct field inspections of portable gauges in use; (5) conduct quarterly inspections of each permanent storage facility and long-term temporary jobsite; (6) provide radiation safety officer training for an authorized gauge user at your Knob Noster facility; and (7) submit periodic reports on the completion of activities to the NRC.

This letter also serves to acknowledge our receipt of your letter dated January 11, 2017 (ML17018A406). We completed our review of your correspondence and have no further questions at this time.

The NRC has concluded that Kruger Technologies, Inc., has satisfied all of the requirements contained in the Order. You are not required to submit any further correspondence to the NRC on this matter.

In accordance with Title 10 of the *Code of Federal Regulations* (CFR) Section 2.390 of the NRC's "Rules of Practice," a copy of this letter will be made available electronically for public inspection in the NRC's Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC's website at <http://www.nrc.gov/reading-rm/adams.html>.
