Dear Mr. Duling:

This letter refers to an inspection conducted from October 1 through December 31, 2016, at the Nuclear Fuel Services, Inc. facility in Erwin, TN. The results of the non-safeguards portion of the inspection will be transmitted under a separate cover letter. The purpose of this inspection was to determine whether activities authorized under the license were conducted safely, and in accordance with U.S. Nuclear Regulatory Commission (NRC) requirements. At the conclusion of the inspection, the findings were discussed with members of your staff at an exit meeting held on January 4, 2017.

The inspection consisted of an examination of activities conducted under the license, as they relate to safeguards and compliance with the Commission's rules and regulations, and with the conditions of the license. Areas examined during the inspection are identified in the enclosed report. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations of activities in progress, and interviews with personnel. No violations were identified in this portion of the report.

This letter and the enclosure contain sensitive unclassified security-related information, and its disclosure to unauthorized individuals could present a security vulnerability.
