Dear Mr. Fenton,

This is in reference to Mr. Young's letter received January 18, 2017, requesting for amendment to Nuclear Regulatory Commission License No. 47-10136-03, Docket No. 03015161. In order to continue our review, we need the following additional information:

1. It appears that there has been a direct change of ownership and the control of the license. In order to access if a change of control has occurred an approve transfer of the license, please provide the following information which is discussed in [NUREG-1556, Volume 15, Revision 1](#), "Consolidated Guidance About Materials Licenses: Guidance About Changes of Control and About Bankruptcy Involving Byproduct, Source, or Special Nuclear Materials Licenses, Final Report," Section 5, and is specifically listed in Appendix E:

Licensees must provide full information and obtain NRC's **prior written consent** before transferring control of the license. Provide the following information concerning changes of control by the applicant (transferor and/or transferee, as appropriate). If any items are not applicable, so state.

- a. Describe any planned changes in the organization, including but not limited to, transfer of stocks or assets and mergers, change in members on Board of Directors, etc. Provide the new licensee name, mailing address, and contact information, including phone numbers. Clearly identify if the amendment request is due to a name change only.
- b. Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel and any changes in the training program.
- c. Describe any changes in the location, facilities, equipment, radiation safety program, use, possession, waste management, or other procedures that relate to the licensed program.
- d. Describe the status of the licensee's facilities, equipment, and radiation safety program, including any known contamination and whether decontamination will occur prior to transfer. Include the status of calibrations, leak tests, area surveys, wipe tests, training, quality control, and related records.
- e. Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to NRC, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.
- f. Confirm that the transferee will abide by all constraints, conditions, requirements, representations, and commitments of the transferor or that the transferee will

submit a complete description of the proposed licensed program.

2. Your amendment request did not specifically request a change of licensee name. Please provide the legal name of the company or confirm that you are not requesting to change the name of the licensee on the license.
3. Please state when the purchase of Cytex Industries Inc. occurred.
4. If Solvay has been previously issued a material license by the NRC or an Agreement State at another facility, please provide the NRC license number and if licensed by an Agreement State, please provide a copy of the license.
5. The NRC has changed the format of its material licenses. Each of your devices will need its own line in items 6, 7, and 8. Please state each device model and the maximum amount of material (activity) you would like to be licensed for that device.

We will continue our review upon receipt of this information. Please reply to my attention at the Region 1 Office (Address below) and refer to Mail Control No. 592823. If you have technical questions regarding this letter, please call me at (610) 337-5366.

Your reply must be an originally signed and dated letter. The letter may be scanned and submitted as a pdf document attached to an email; or it may be transmitted by facsimile to (610) 337-5269; or it may be sent by regular mail. If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application OR amendment request.
