Dear Ms Pelke:

I am requesting three amendment be made to our current license.

1. In section 1 of the Materials License: the name of our company has changed, as of January 2017, from St. Marys Cement, Inc. (US) to St. Marys Cement U.S. LLC
2. This year, we need to do source replenishment on both analyzers that are listed in the License and would like to do the replenishment at the same time so that our plant production is not stopped. In section 8 of our Materials License has a limit of 6 sources, of CF-252, not to exceed a total possession limit of 148 mill curies. Each analyzer holds up to 4 sources. We request that the total maximum number of sources listed in the License be increased to 12, (6 sources per analyzer to accommodate for us to receive the source replenishment and give us some flexibility in date of installment), with the same limit of 148 mill curies.
3. In Section 9 we would like to update the device manufacturer's name to Thermo Gamma Metrics as they have changed their name.
