Gentlemen:

Niagara Mohawk submitted a proposed radwaste reduction system modification for Nuclear Regulatory Commission approval on September 1, 1978. In a letter dated October 30, 1978 from W. O. Miller to D. P. Dise, the Commission requested payment of \$12,300 for their review. This payment was made on November 7, 1978 by Niagara Mohawk check # 251131. The payment reflects a Class IV Amendment according to the schedule of fees set forth in 10CFR170.22.

Niagara Mohawk's position is that the request for approval, submitted pursuant to 10CFR20.305, is a Class III request for approval and does not involve a license amendment. The subject of this request for approval was submitted for NRC generic review in a topical report submitted in June 1977 by Newport News Industrial. As a result of our technical evaluation, Niagara Mohawk is of the opinion that this request for approval is one which involves a single environmental issue. Approval of the Radwaste Reduction System should fall into Class III of 10CFR170.22, for which the corresponding fee is \$4,000. Niagara Mohawk respectfully requests the \$8,300 difference between the categories be refunded immediately.
