This refers to your license amendment request dated January 11, 2017. Please find enclosed Amendment No. 7 authorizing Annmarie Alcala as the Radiation Safety Officer and the Authorized User. Additionally, Conditions 17 and 18 were added, which are standard license conditions when using sealed sources.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
