 its accounts payable and notes payable.

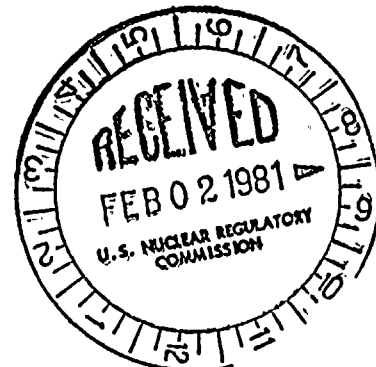

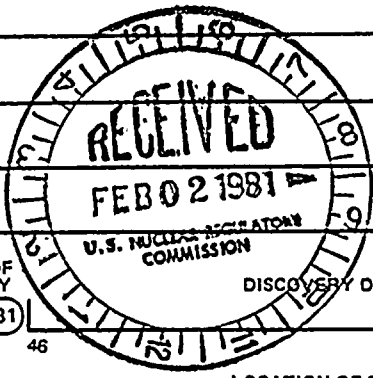
