Dear Mr. Ippolito:

Our letters of May 14 and August 31, 1979 regarding Inspection and Enforcement Bulletin 79-08 indicated that Niagara Mohawk would install automatic isolation valves on two lines by the end of the next refueling outage. This commitment also appears in our letter of December 17, 1980. These lines include the sample line to the reactor recirculation line and the suppression chamber pump down line. These lines contain valves which are normally closed except during sampling or suppression chamber pump down.

Due to equipment delivery problems, these modifications will not be completed until March 1, 1982.

Until the modifications are complete, Niagara Mohawk will utilize the administrative controls outlined in our previous responses to assure containment isolation capability.
