Dear Mr. Schwencer:

This letter is to inform you that Nine Mile Point Unit 2 is taking exception to Section 8.2, "Marking and Identification", of ASTM SA 354, 1974 edition. This section presently allows the same standard six radial lines marking to be used for both Grade BD and J429 Grade 8 bolts. This identical marking for both bolts causes material identification control problems since the Grade BD bolt is ASME qualified, while the other is not.

The exception Nine Mile Point Unit 2 is taking is to allow, in the future, lots of Grade BD bolts be marked with either the standard six radial lines or with "BD" on the bolt head. The "BD" marking is preferred because this eliminates any question as to the type and qualification of the bolt.
