
Your letter of April 26, 1982 requested information regarding descriptions of modifications required to meet Section III.G.3 of Appendix R to 10CFR50 for Nine Mile Point Unit 1. Due to the scope of work, additional time is required to perform the requested analyses. Based on our current estimate, this information will not be available until July 1, 1983.

In discussions with members of your staff, it was indicated that our submittal date for this requested information could extend beyond the 60 days stated in your letter, as long as there would be no impact on the date at which final modifications would be completed.

The next planned refueling outage for Nine Mile Point Unit 1 will not commence until early 1984. Based on the implementation schedule of 50.48(c)(4), modifications would be required to be completed by the end of that outage. Our preliminary indication is that only cable changes would be required which could be done in one outage. Therefore, based on our revised submittal date of July 1, 1983, implementation of modifications by the end of the 1984 outage would not be impacted.
