Subject: Management Meeting on Nine Mile Point 2 Application

The NRC staff recently established the practice of holding a management meeting with an applicant upon completion of the acceptance review of a tendered application. The purpose of the meeting is to discuss the plans for the licensing review of the OL application, and to provide the NRC staff management with the opportunity to air views on specific issues which may be of particular concern in the review.

The staff would like to meet with Niagara Mohawk Power Corporation on April 28, 1983. The NRC licensing project manager will contact the Nine Mile Point 2 licensing engineer regarding the specific arrangements. Because of the difficulty in arranging the meeting to be consistent with the schedules of NRC Division Directors, the meeting will be scheduled to last only one hour. Other members of the staff will be available throughout the day for detailed discussions if necessary. The licensing project manager will prepare a meeting agenda.

You should prepare a brief presentation on the status of Nine Hile Point 2 to be directed toward our Division Directors. I suggest you highlight the following information:

- Nine Mile Point 2 construction status.
- Nine Mile Point 2 design basics including similarities to other plants undergoing licensing review or recently licensed.


