Gentlemen:

We have received a copy of your application dated September 26, 1983, which was filed with the Office of Nuclear Reactor Regulation (ONRR) for review. This application proposed certain Technical Specification changes relating to reporting requirements for reactor vessel material surveillance specimen for the Nine Mile Point Nuclear Station Unit No. 1. Although your application states that a check for \$1,200 for a Class II fee was enclosed as part of your submittal, this check has not been received by us.

Based on information provided by the ONRR staff as the result of their preliminary review of your application, they agree with your determination that a Class II fee (\$1,200) is appropriate since the changes are administrative in nature.
