Dear Mr. Vassallo:

Pursuant to discussion with members of your staff, the following information is provided to reconfirm and where appropriate, update schedules contained in past Niagara Mohawk submittals.

1. Safety Parameter Display System - Niagara Mohawk intends to have the Safety Parameter Display System fully operational, including operator training, by the end of the 1986 refueling outage.
2. Emergency Response Facilities
 - a) Operational Support Center - The Nine Mile Point Unit 1 Operational Support Center is currently fully functional.
 - b) Technical Support Center - Niagara Mohawk will provide the Nuclear Regulatory Commission with an implementation schedule for a fully operational Technical Support Center by May 1, 1984.
 - c) Emergency Operations Facility - A new Emergency Operations Facility for Nine Mile Point is currently under construction. Niagara Mohawk intends to have the new Emergency Operations Facility fully equipped and operational by December 31, 1985.
