Niagara Mohawk hereby withdraws the following outstanding applications for amendment to Operating License DPR-63:

1. July 15, 1977 application regarding diesel generator instrumentation setpoints
2. January 16, 1977 application on safety relief valve surveillance requirements

Several discussions have been held with members of your staff regarding the status of these applications. Based on those discussions the following actions are being taken.

1. Existing diesel generator instrument setpoint logic is currently being modified. This modification involves a revision to the July 15, 1977 application. A revised technical specification application will be provided by April 1, 1984.
2. The current technical specifications on the relief valves have been revised in accordance with discussions with your staff. The revised technical specifications will be submitted by April 1, 1984.

In addition, as discussed with your staff, Niagara Mohawk intends to submit additional information to supplement and clarify our May 22, 1980 application regarding reactor low-low-low water level indicator scale. The additional information will be submitted by April 1, 1984.
