This submittal replaces, in its entirety, the Niagara Mohawk Power Corporation Quality Assurance Program Manual submitted on June 10, 1983. Changes made to last year's manual are indicated by vertical marginal markings. Vertical bars are not placed next to format changes or corrections of typographical errors.

Please note Section XVI indicates that implementation of the deficiency and corrective action system are the responsibility of the Quality Assurance Department and the Nuclear Generation Department. The previous submittal indicated it was the sole responsibility of the Quality Assurance Department. Full implementation of this revision is not expected until the end of this year.
