Recently, Mr. Terao, of the Commission staff, has identified a potential concern regarding the location of the Nine Mile Point Unit 2 reactor water cleanup isolation valve. Specifically, Mr. Terao was concerned about the distance from the reactor water cleanup valve to the primary containment and the definition of the break exclusion area for this line as it is attached to the feedwater lines. Based upon our review of this matter, we feel it is appropriate to set up a meeting with the NRC staff to resolve this concern. We will work with the NRC Project Manager to set up this meeting and resolve this matter expeditiously.
