

This letter refers to the routine safety inspection conducted by Mr. H. Gregg of this office on April 13-17, 1987, at the Nine Mile Point Nuclear Station, Unit 2, Scriba, New York. Mr. Gregg discussed the findings of the inspection with Mr. M. Ray and other members of your staff at the conclusion of the onsite inspection.

The objective of this inspection was to follow-up on your activities related to installation of the new Rockwell "Y" pattern globe type Main Steam Isolation Valves (MISVs). These new valves have replaced the Crosby ball type MSIVs. Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.


