Dear Mr. Zwolinski:

Our May 2, 1983 letter requested an amendment to the Nine Mile Point Unit 1 License regarding a change in the surveillance requirements for the Nine Mile Point Unit 1 reactor vessel material samples. However, during the spring 1986 refueling outage, additional surveillance capsules and material samples are being installed in the reactor vessel. Since the current surveillance requirements can be met, the request for amendment dated May 2, 1983 is no longer required. Therefore, pursuant to 10CFR2.107, Niagara Mohawk withdraws the request for amendment to Operating License DPR-63 dated May 2, 1983.
