This refers to the meeting held at our request at the Nine Mile Point Unit 2 site, Scriba, New York on January 22, 1986 relating to activities authorized by NRC License No. CPPR-112. The subjects discussed at this meeting are included in NRC Management Meeting Report No. 50-410/86-06.

This meeting served as a forum to discuss the plant status with respect to construction completion, preoperational test program status, and operational readiness. The Region I Near Term Operating License (NTOL) Review Panel will assess current plant status and projected activity completion dates to assure coincident completion of Region I inspection activities.

Our tours of the facility indicate that greater attention should be focused in the housekeeping area to preclude degraded equipment cleanliness levels.

We appreciate the level of effort that your staff devoted to the compilation of information that was discussed at our meeting.
