On October 1, 1984, Niagara Mohawk responded to Generic Letter 84-15. To increase the reliability of our emergency diesel generators, Niagara Mohawk committed to upgrading the prelubrication system during the 1986 refueling and maintenance outage. We indicated the completed modification would use AC lube oil pumps, with DC backups, to continuously circulate oil inside of each diesel generator. After additional evaluation, we have determined that following a loss of AC power, a momentary lack of lube oil circulation could result before satisfactory lube oil pressure is established by the diesel engine main lube oil header or the backup DC pumps.

Therefore, Niagara Mohawk has decided to utilize DC pumps as the primary method of circulating oil by the prelubrication system in lieu of the AC pumps initially specified. The DC pumps will maintain a constant supply of prelubrication oil to the diesel engine despite the loss of AC power. This modified design is consistent with Section 9.5.7, "Emergency Diesel Engine Lubrication System," of the Standard Review Plan, Part III.l.h(1) and will be installed in accordance with the above implementation schedule.
