APPLICATION FOR AMENDMENT

TO

OPERATING LICENSE

Pursuant to Section 50.90 of the regulations of the Nuclear Regulatory Commission, Niagara Mohawk Power Corporation, holder of Facility Operating License No. DPR-63, hereby requests that Specification 6.12 and Tables 3.6.2a, 3.6.2b, 3.6.2h and the notes for these three tables of the Technical Specifications set forth in Appendix A to that License be amended. This proposed change has been reviewed in accordance with Section 6.5 of the Technical Specifications.

The proposed Technical Specification changes are set forth in Attachment A to this application. Specification 6.12 and Tables 3.6.2a, 3.6.2b, 3.6.2h and the notes for these tables are being proposed for amendment in order to demonstrate the feasibility of a Hydrogen Water Chemistry System in mitigating intergranular stress corrosion cracking of stainless steel piping at Nine Mile Point Unit 1. Supporting information and analysis which demonstrate that the proposed changes (i.e. changes to the main steam line high radiation scram and isolation setpoints) involve no significant hazards considerations pursuant to 10CFR50.92, are included as Attachment B.
