Niagara Mohawk Power Corporation intends to make use of ASME Code Cases N-341 and N-356, approved June 17, 1982 and June 16, 1982, respectively, to extend the certification period of Level III examiners from three years to five years.

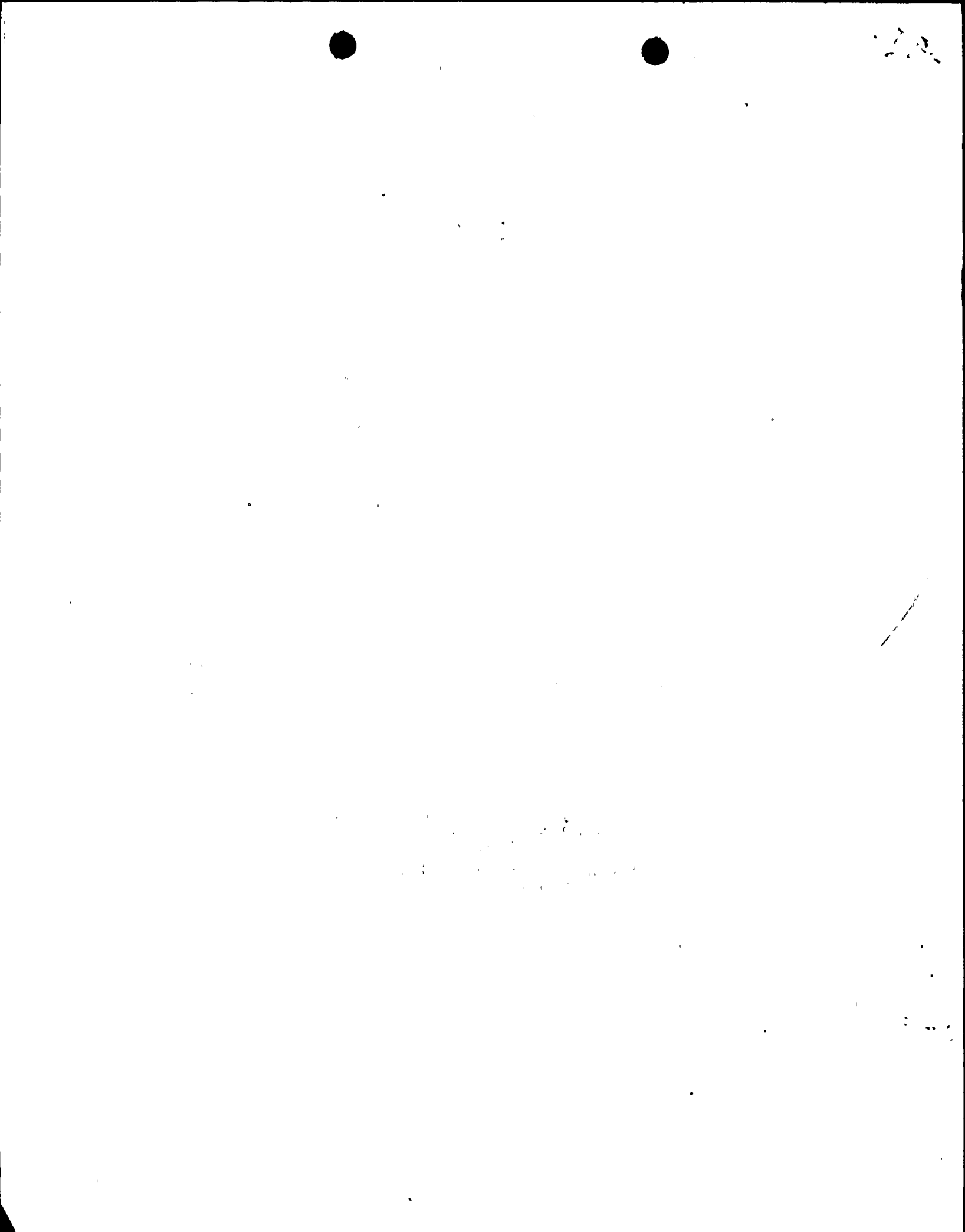
We request Nuclear Regulatory Commission approval for use of ASME Code Cases N-341 and N-356 at the Nine Mile Point Nuclear Power Station Unit 2 for the following applications:

- N-341 To extend Level III examiner's certifications to five (5) years for ASME Section III, Divisions 1 and 2
- N-356 To extend Level III examiner's certifications to five (5) years for ASME Section XI, Divisions 1, 2 and 3

Use of the above code cases was approved for the Clinton Power Station in April 1983. Code Case N-356 was incorporated into ASME Section XI in the winter 1983 addenda.
