Dear Mr. Zwolinski:

Our letter of June 13, 1986 provided details of the completion schedule for the human engineering observations (HEO's) associated with the Control Room Design Review for Nine Mile Point Unit 1. We indicated that we would notify you promptly should unexpected changes occur to this schedule.

On June 13, 1986, members of my staff notified you that the list of HEO fixes scheduled for completion in 1988 contained in our previous letter needed to be expanded. This was due to last-minute procurement and installation constraints.

The following HEO fixes have been added to the list referenced above:

- OCS 145 - replace scale on recirculation flow recorder
- OCS 172 - replace scale on air header scram solenoid pressure recorder
- OCS 126 - replace scale on temperature recorder
- OCS 175 - replace chart paper on offgas flow recorder
- OCS 178 - replace chart paper on kilovolt recorder
- OCS 179 - replace chart paper on drywell pressure dewpoint recorder
- OCS 180 - replace chart paper on pump discharge pressure recorder
- QS 009 - improve operability of H₂O₂, radiation, and turbine speed indicators/recorders.


