This letter responds to a Nuclear Regulatory Commission staff question pertaining to Nine Mile Point Unit 2 regarding the applicability of the BWR Owners Group (BWROG) testing of reactor coolant recirculation system pump seals. This testing was referenced in the Nine Mile Point Unit 2 Final Safety Analysis Report Section 1.10 position for NUREG-0737, Item II.K.3.25. Niagara Mohawk evaluated the testing results and determined they were applicable to Unit 2. That evaluation was based in part by the letters referenced in the Final Safety Analysis Report and was also supported by a Safety Evaluation Report issued by the Nuclear Regulatory Commission on January 25, 1983. That SER accepted the testing performed on pumps manufactured by the Bingham Pump Company and Table 1 to the SER shows those pumps as the ones supplied for Unit 2.
