


In a September 3, 1986 and September 10, 1986 letter from M. F. Haughey to C. V. Mangan, the NRC staff provided responses to a number of the SER comments we identified in our July 16, 1986 letter to you. During subsequent discussions with the NRC staff, informal responses were provided for several other of our SER comments. This letter provides a status report of our evaluation of your responses. Where additional information or Final Safety Analysis Report changes are needed to resolve an item, it will be provided by separate transmittal.

We have categorized the status of the SER comments based on the actions which are required to reach resolution as follows:

Category V: No response has been received from NRC, or the response is not complete.


