On October 15, 1986, Niagara Mohawk Power Corporation submitted to you a request for a schedular exemption in letter NMP2L 0909 to permit the completion of construction, testing and post test review for the installation of certain redundant Class 1E protective devices and components prior to completion of the "mini-outage". 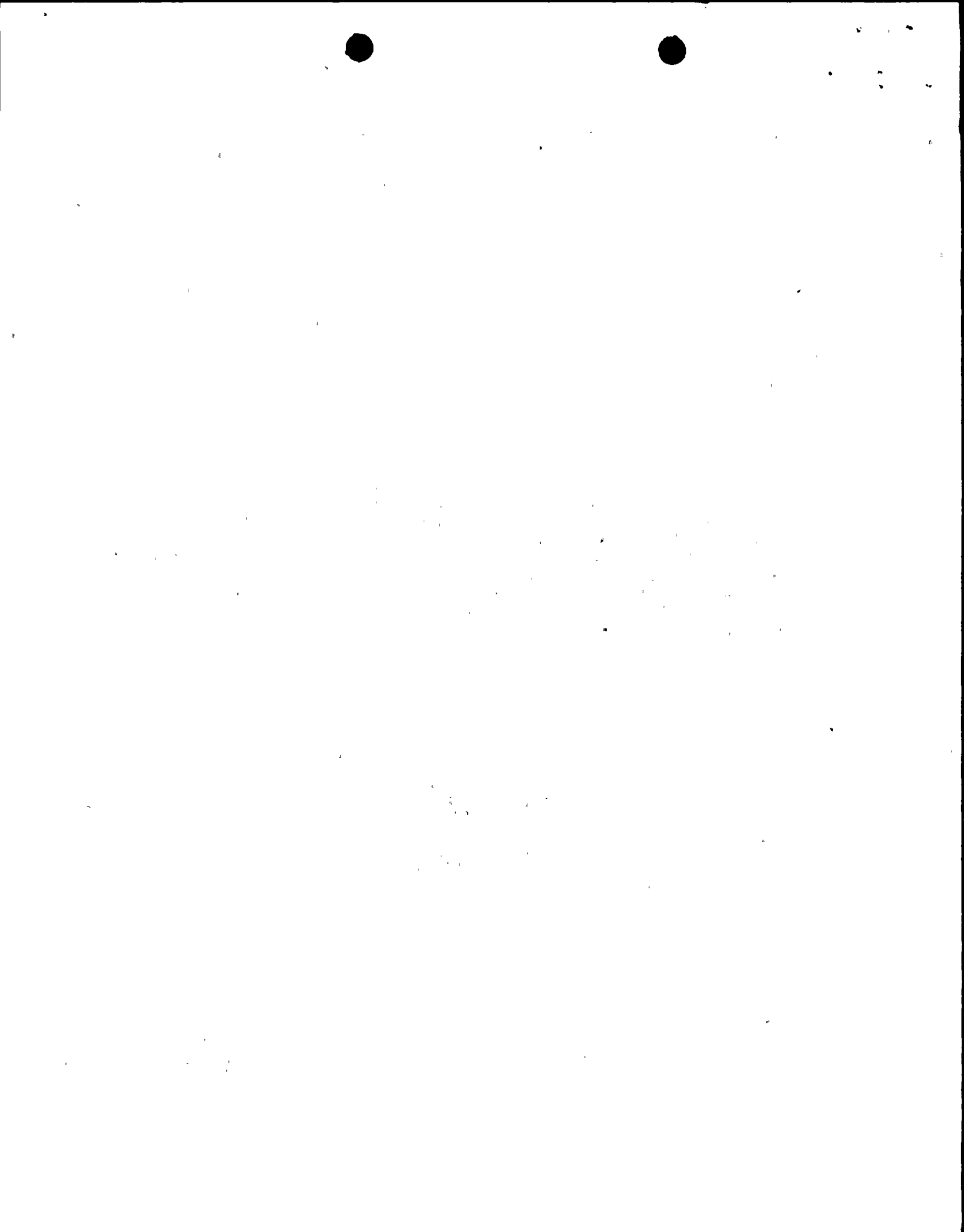
