Pursuant to Section 50.90 of the regulations of the Nuclear Regulatory Commission, Niagara Mohawk Power Corporation, holder of Facility Operating License No. DPR-63, hereby requests that Figures 2.1.1 and 3.1.7.aa of the Technical Specifications set forth in Appendix A to that license be amended. The proposed changes have been reviewed in accordance with Section 6.5 of the Technical Specifications.

The proposed Technical Specification changes are set forth in Attachment A to this application. Figures 2.1.1 and 3.1.7.aa are being proposed for amendment in order to prevent unnecessary restriction of operating ranges and provide consistency with the current reload analyses for the present Nine Mile Point Unit 1 core configuration and parameters. Supporting information and analysis which demonstrate that the proposed changes involve no significant hazards considerations pursuant to 10CFR50.92, are included as Attachment B.
