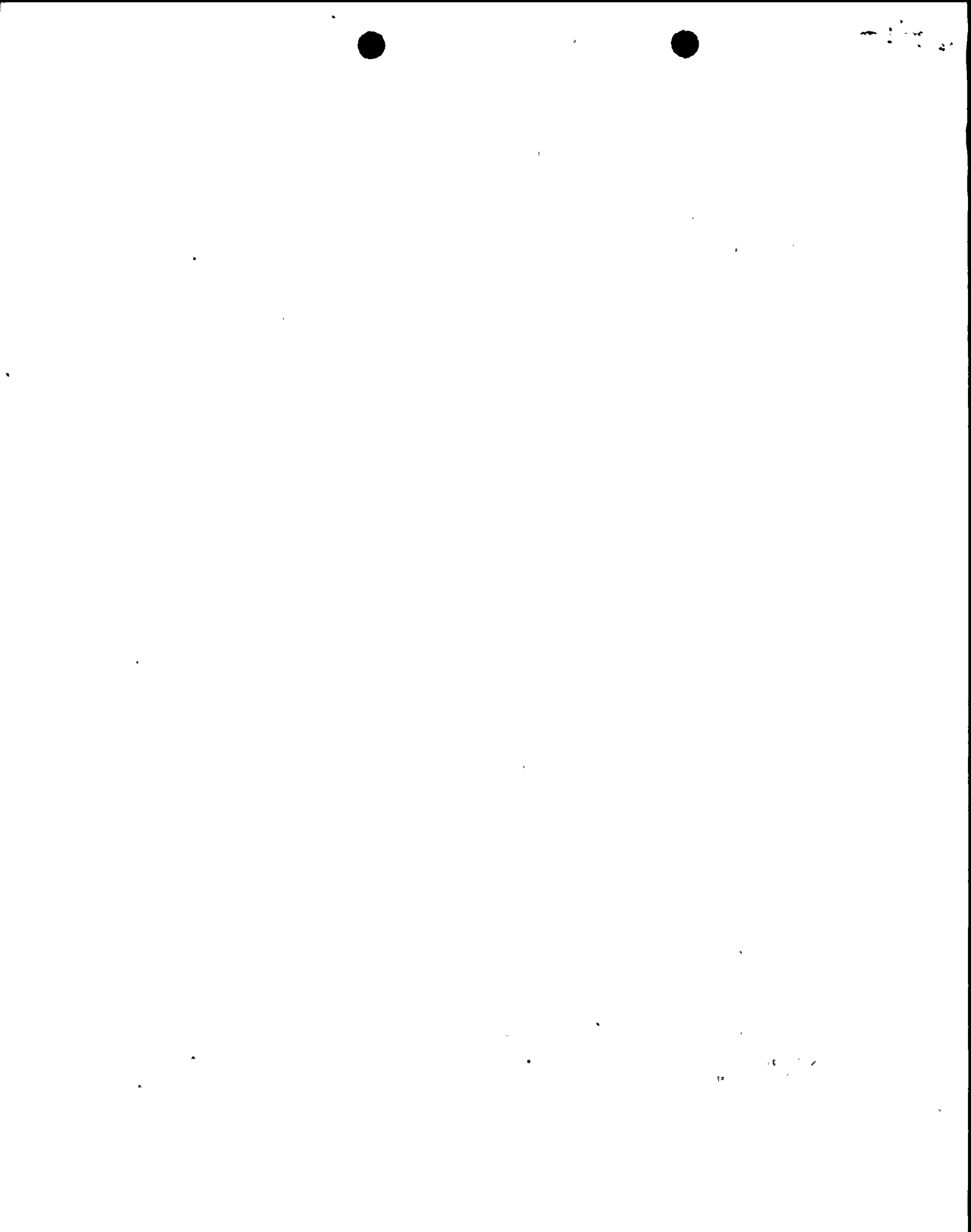

Subject: Change to Technical Specifications 6.5.3.10.a and 6.5.3.10.b,  
Administrative Controls Section

The requested changes are attached. The changes are being requested in order to make Nine Mile Point Unit 2 Technical Specifications consistent with Nine Mile Point Unit 1 Technical Specifications in the area of maximum allowable time for issuance of SRAB minutes and audit reports. Niagara Mohawk believes that the 14 day/30 day requirement for SRAB minutes/audit reports, respectively, is too short of a time limit given the review of minutes/audit reports that need to be performed prior to their official issuance.
