By letters dated April 7 and June 13, 1986, Niagara Mohawk Power Corporation requested the deferral of preoperational testing of several systems until after the initial fuel load. For the Containment Inerting System, Niagara Mohawk Power Corporation committed to preoperational testing of this system within 6 months after fuel load, but before operation above 5% of rated thermal power. This letter provides the certification of completion for the Containment Inerting System. An Affidavit to this certification accompanies this letter.

Containment Inerting System

The preoperational test of the Containment Inerting System has been completed, reviewed and approved. This preoperational test was performed in accordance with the approved Nine Mile Point 2 Preoperational Test Procedure (N2-POT-88). The test results were reviewed and approved by the Joint Test Group (JTG) and the Site Operations Review Committee (SORC). The Site Operations Review Committee review and operational acceptance sign-off was completed on November 6, 1986. The Station Superintendent's review and operational acceptance sign-off was completed on November 16, 1986.
