Niagara Mohawk Power Corporation withdraws its request for a schedular exemption for the DBA Hydrogen Recombiner System contained in our letter dated December 5, 1986 (NMP2L 0946).

Niagara Mohawk Power Corporation has submitted a final report concerning insufficient flow rate for the hydrogen recombiners (55(e)-86-22) dated January 6, 1987 (NMP2L 0965) to Region I of the Nuclear Regulatory Commission. This report states that the DBA hydrogen recombiners meet their design requirements with regard to both flow and heatup rate as specified in the Final Safety Analysis Report (FSAR) and Technical Specifications, and provides a description of actions taken to resolve earlier discrepancies. Based on the information provided in the above report, the requested exemption is no longer required.
