
Gentlemen:

Niagara Mohawk requested schedular exemptions to permit operation of Nine Mile Point Unit 2 prior to the completion of certain activities. For the schedular exemptions described in paragraphs 2.D. iv), v), vi), vi), and viii) of our facility license Docket No. 50-410, Niagara Mohawk Power Corporation, committed (letter of October 31, 1986, NMP2L 0931), to certify to the Nuclear Regulatory Commission, ten days prior to the expiration period specified in the exemption, that the required activity has been completed and the associated systems are complete and operable. This letter provides the certification of completion for the Turbine Electrical Hydraulic System. The above mentioned system, which involved an exemption permitting completion to be delayed until before both of the main steam isolation valves have been opened, following plant startup, is now completed. The remainder of this letter provides a summary description of the actions taken to assure that the regulations have been met regarding operability of this system.

## Turbine Electrical Hydraulic Control System

In a letter dated July 2, 1986, Niagara Mohawk requested an exemption from the requirements of 10 CFR 50, Appendix A, GDC 4 and 29 in order to defer operability of the Turbine Electrical Hydraulic Control (EHC) System until before both of the main steam isolation valves (MSIVs) are opened following plant startup. The appropriate exemption was granted by the Nuclear Regulatory Commission Staff.

The preoperational test of the Turbine Electrical Hydraulic Control System has now been completed, reviewed and approved. This preoperational test was performed in accordance with the approved Nine Mile Point 2 Preoperational Test Procedure (N2-POT-23). The test results were reviewed and approved by the Joint Test Group (JTG) and the Site Operations Review Committee (SORC). The final Site Operations Review Committee review and operational acceptance sign-off was completed on December 11, 1986. The Station Superintendent's review and operational acceptance sign-off was completed on January 29, 1987.
