Generic Letter 86-10, Implementation of Fire Protection Requirements, dated April 24, 1986, indicated that each licensee should incorporate the fire protection program that has been approved by the Nuclear Regulatory Commission into their Final Safety Analysis Report update. The Generic Letter further indicated that this incorporation should include the Fire Hazards Analysis and major commitments that form the basis for the Fire Protection Program. The incorporation could be by reference to specific previous submittals and the NRC approvals where appropriate, and was to be included in the Final Safety Analysis Report update required by 10CFR50.71(e) that will fall due more than six (6) months after the date of Generic Letter 86-10.

In this year's revision to the Final Safety Analysis Report, Niagara Mohawk referenced the previously submitted Fire Protection Program. However, we are currently updating the Fire Hazards Analysis to reflect recent plant modifications. The new version, scheduled for completion in October 1987, will be submitted to you, and that submittal will then be referenced on our Final Safety Analysis Report update in June 1988.
