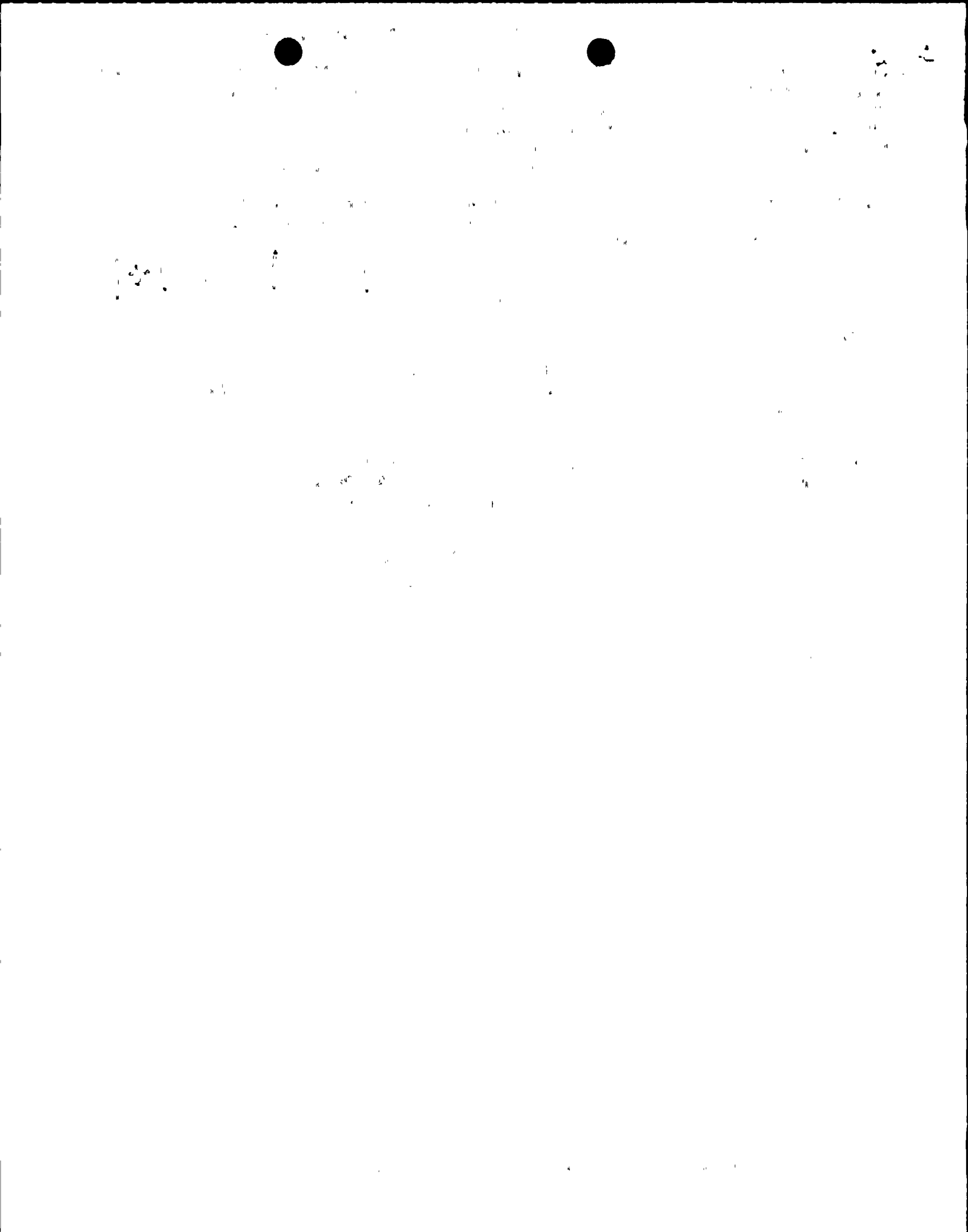

Niagara Mohawk's letter of February 17, 1987 (NMP1L 0135) transmitted proposed changes to the Nine Mile Point Unit 1 Technical Specifications. The proposed technical specification changes involve revisions to Specification 3.6.2, Protective Instrumentation and Specification 3.6.14, Radioactive Effluent Instrumentation.
