

Subject: Systematic Assessment of Licensee Performance (SALP); Report No. 50-410/86-99

This refers to the assessment we conducted of the activities at the Nine Mile Point Unit 2 Nuclear Power Plant, for the period February 1, 1986 to January 31, 1987. This report was discussed with you at a meeting on June 12, 1987 at the Niagara Mohawk Training Center in Scriba, New York. The list of attendees is attached as Enclosure 1. Your written comments on our report have been reviewed and are attached as Enclosure 2. The SALP report was forwarded to you for review by our letter of May 15, 1987 (Enclosure 3) and is attached (unrevised) as Enclosure 4.

Our overall assessment of your facility operation concludes that increased management attention is needed in several functional areas. Weaknesses were noted, and acknowledged, in operations, surveillance testing and licensing activities. Your letter of June 25, 1987 addressed the corrective actions you have taken and planned, regarding these areas, and we plan to pay particular attention to your progress in these areas.

No reply to this letter is required. Your actions in response to the NRC Systematic Assessment of Licensee Performance will be reviewed during future inspections of your licensed facility.




