The proposed amendment reflected a change in the surveillance requirements for the Nine Mile Point Unit 1 reactor vessel material samples because one of the sample capsules had been inadvertently misplaced during a previous refueling outage.

During the Spring 1986 refueling outage, additional surveillance capsules and material samples were installed in the reactor vessel. Since the current surveillance requirements can be met, the request for amendment is no longer required. By letter dated January 29, 1986, Niagara Mohawk withdrew the May 2, 1983 request for amendment.
