Gentlemen:

On October 17, 1988 we submitted a response to additional Commission questions on Generic Letter No. 83-28. In that response we agreed to provide a description of a program that would cover upgrading of the present Q-list at Nine Mile Point Unit 1.

An Engineering Program Integration plan has been drafted. Part of this effort is to reconstitute the Design Basis for Nine Mile Point Unit 1 and to upgrade our configuration management system. One of the activities in this plan is a review and upgrade of the present Q-list for Unit 1. The Q-list is a key document to this overall plan and must be integrated with other related activities to assure consistency and completeness. We plan to do this on a prioritized system-by-system basis.

The Engineering Program Integration plan is in the process of being finalized. We intend to present our plan to the NRC between now and June 1989.
