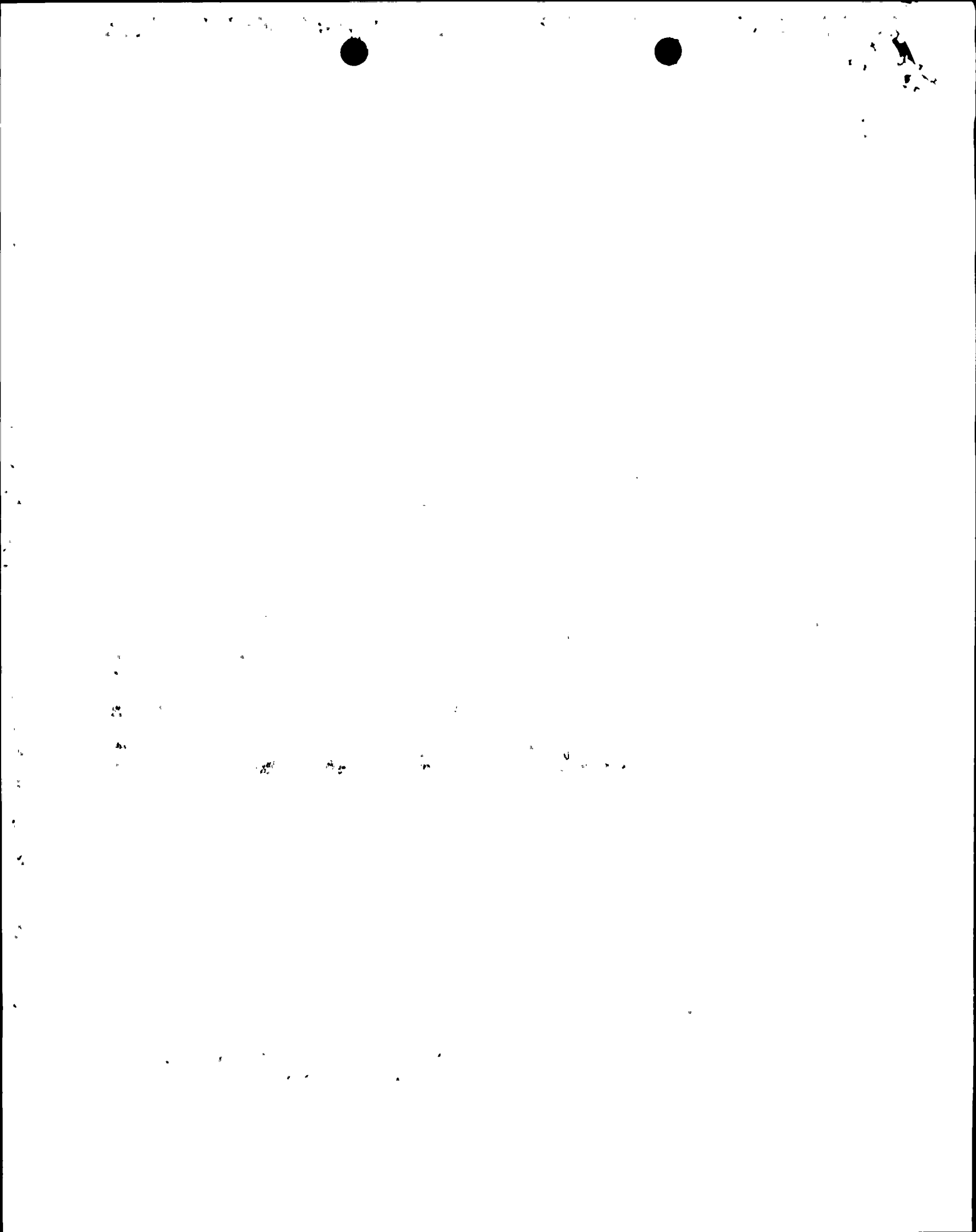

Gentlemen:

Niagara Mohawk Power Corporation hereby transmits an application for amendment to Nine Mile Point Unit 2 Operating License NPF-69. Also enclosed are the proposed changes to the Technical Specifications and accompanying Bases in Appendix A of the above mentioned license. Supporting information and analyses demonstrating that the proposed changes involve no significant hazards consideration pursuant to 10CFR50.92 are included as Attachment B.

The proposed Technical Specification changes contained herein represent revisions to Table 2.2.1-1 Reactor Protection System Instrumentation Setpoints, Specifications 3/4 Average Planar Linear Heat Generation Rates, Average Power Range Monitor Setpoints, Minimum Critical Power Ratio (ODYN Option B), Linear Heat Generation Rate, Control Rod Block, Section 5 Reactor Core, and 6.9 Administrative Controls. The associated Bases are also changed.

The proposed changes implement NRC Generic Letter 88-16, "Removal of Cycle-Specific Parameter Limits from Technical Specifications."

Enclosed with this submittal is a draft of the Core Operating Limits Report for Nine Mile Point Unit 2. The procedures for control and review of this report are under development and will be in place prior to restart from the Spring, 1990 refueling outage.
