Gentlemen:

On September 21, 1990, Niagara Mohawk submitted an Application for Amendment to the Nine Mile Point Unit 2 Operating License NPF-69. This application contained proposed revisions to the Administrative Controls Section of the Technical Specifications to reflect management changes due to the reorganization of Niagara Mohawk's Nuclear Division and to provide consistency with the standard technical specifications (NUREG-0123).

Our Application included a proposed change to Section 6.2.2.i such that the review of individual overtime on a monthly basis to assure that excessive hours have not been assigned would be handled by procedure rather than the General Superintendent - Nuclear Generation.

As requested by your staff, attached is a revised Technical Specification page 6-3 which replaces page 6-3 of our September 21, 1990 Application. This revised page includes the requirement for a monthly review of individual overtime by the Vice President - Nuclear Generation or a designee to assure that excessive hours have not been assigned.
