Niagara Mohawk Power Corporation hereby transmits an application for amendment to Nine Mile Point Unit 1 Operating License DPR-63. Also enclosed are the proposed changes to the Technical Specifications in Appendix A of the above mentioned license. Supporting information and analyses demonstrating that the proposed changes involve no significant hazards consideration pursuant to 10CFR50.92 are included as Attachment B.


The proposed Technical Specification changes contained herein represent revisions to Sections 3.2.7 Reactor Coolant System Isolation Valves, 3.2.7.1 Primary Coolant System Pressure Isolation Valves, 3.3.3 Leakage Rate and 3.3.4 Primary Containment Isolation Valves. Changes are also proposed for the associated Bases for Sections 3.3.3 and 3.3.4. The proposed amendment is submitted to update the reactor coolant system and primary containment isolation valve tables and to conform to the requirements of 10CFR50 Appendix J and the NRC's SER dated May 6, 1988.

This submittal supersedes our submittals dated November 13, 1985, August 27, 1984 and November 1, 1983.

Pursuant to 10CFR50.91(b)(1), Niagara Mohawk has provided a copy of this license amendment request and the associated analyses regarding no significant hazard considerations to the appropriate state representative.
