Temps from November 15, 1990 through January 3, 1991, at Nine Mile Point Units 1 and 2, Scriba, New York. Overall performance during this inspection period was satisfactory, despite two personnel errors which led to a Unit 1 scram and a Unit 2 inadvertant safety feature actuation. Niagara Mohawk management response and corrective actions for these events were appropriate.
