

Gentlemen:

In accordance with 10CFR50.73, we hereby submit the following Licensee Event Report:

LER 91-17 Supplement 1 Is being submitted in accordance with the following: 1) 10CFR50.73

(a)(2)(iv), "Any event or condition that resulted in manual or automatic actuation of any Engineered Safety Feature (ESF) including the Reactor Protection System (RPS)"; and 2) 10CFR50.73 (a)(2)(i)(B), "Any operation or

condition prohibited by the plant's Technical Specifications".

This supplement is being issued to provide the root causes for two missed Technical Specification requirements and to provide the results of the root cause investigation for the "B" Phase Main Transformer.

A 10CFR50.72 (a)(1)(i) report was made at 0612 hours on August 13, 1991.

Additionally, events were reported on a continuing basis as an open phone line was maintained between the plant and the U.S. Nuclear Regulatory Commission.

This report was completed in the format designated in NUREG 1022, Supplement 2, dated September 1985.
