Subject: Service Water System Problems Affecting Safety-Related Equipment (Generic Letter 89-13)

The Nuclear Regulatory Commission (NRC), via Generic Letter 89-13, recommended several actions be taken by licensees to ensure that their service water systems were in compliance with applicable General Design Criteria. Generic Letter 89-13 also required that licensees confirm to the NRC within 30 days of completion that all recommended actions or their justified alternatives have been implemented. The purpose of this letter is to inform you that Generic Letter 89-13 required tests or activities have been implemented and that required continuing programs have been established as indicated in our letter dated December 10, 1990.

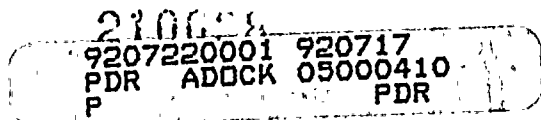
