SUBJECT: WORK CONTROL MONITORING PROGRAM AT NINE MILE POINT

In our March 11, 1992 (NMP1L 0650) and June 22, 1992 (NMP1L 0673) letters to the NRC, we discussed our Work Control Monitoring Program that we are implementing relative to Unit 1's Loss of Ultimate Heat Sink event. During the time that the Work Control Monitoring Program has been in effect, an improving trend in the quality and completeness of work packages has been exhibited.

Niagara Mohawk is presently undertaking actions to streamline and simplify the process and procedures which implement the Work Control Monitoring Program. The week of July 20, 1992 will be the last week that the Work Control Monitoring surveillances will be performed. Beginning in August, 1992, the Work Control Monitoring special surveillance frequencies will be performed at each plant on a monthly basis. Once the streamlined changes to the procedures have been approved and issued, and personnel trained, the frequency of the Quality Assurance surveillances of the work control activities will be increased to two per month per plant to provide the appropriate interaction, clarify understanding of the changes and assure that we are carrying out the intent of the streamlining and simplification of the Work Control Process. This level of surveillance will continue until Senior Management is satisfied that the Work Control Monitoring process enhancements are being effectively carried out. Niagara Mohawk feels that streamlining and simplifying the Work Control process will continue to strengthen our overall work process activities at Nine Mile Point.
