Gentlemen:

On July 26, 1993, the Nuclear Regulatory Commission issued Amendment No. 143 to the Nine Mile Point Unit 1 Operating License DPR-63. The issued Technical Specification pages had been forwarded to the Staff by Niagara Mohawk by letter dated June 30, 1993 (NMP1L 0767). This letter supplemented our original Technical Specification amendment applications concerning the re-typed Technical Specifications and Bases (Amendment No. 142) and the revised correlations for the flow biased scram and rod block functions (Amendment No. 143). The June 30, 1993 letter provided two sets of revised pages. The first set incorporated Staff comments on Amendment No. 142, which was subsequently issued on July 14, 1993. The second set of pages incorporated the proposed changes associated with Amendment No. 143 into the revised pages of Amendment No. 142.

Niagara Mohawk has identified errors on four of the pages associated with Amendment No. 143. The June 30, 1993 submittal had proposed the deletion of an entire paragraph on page 26 as part of Amendment No. 142. The version of page 26 provided for Amendment No. 143 failed to incorporate that change. In addition, typographical errors were made on pages 18 and 197, and the marginal marking for Section 2.1.2i on page 21 was inappropriately shortened by one line when the changes for Amendment No. 143 were transposed into the pages of Amendment No. 142.

Enclosed are corrected versions of pages 18, 21, 26 and 197. Niagara Mohawk apologizes for any inconvenience caused by these errors.
