This is to inform you of a realignment of site project responsibility within the NRC Region I Office Division of Reactor Projects (DRP) regarding the Nine Mile Point Nuclear Power Station. Effective July 28, 1996, Nine Mile Point Nuclear Power Station will be assigned to Projects Branch 1, DRP. The Branch Chief is Larry Doerflein. As of the effective date, Projects Branch 1 will consist of the Nine Mile Point Nuclear Power Station, the Calvert Cliffs Nuclear Power Plant, and the R.E. Ginna Nuclear Power Plant.

The assignment of Nine Mile Point Nuclear Power Station to Projects Branch 1 was made to enhance oversight and effectiveness, and balance the workload, within the Division of Reactor Projects.

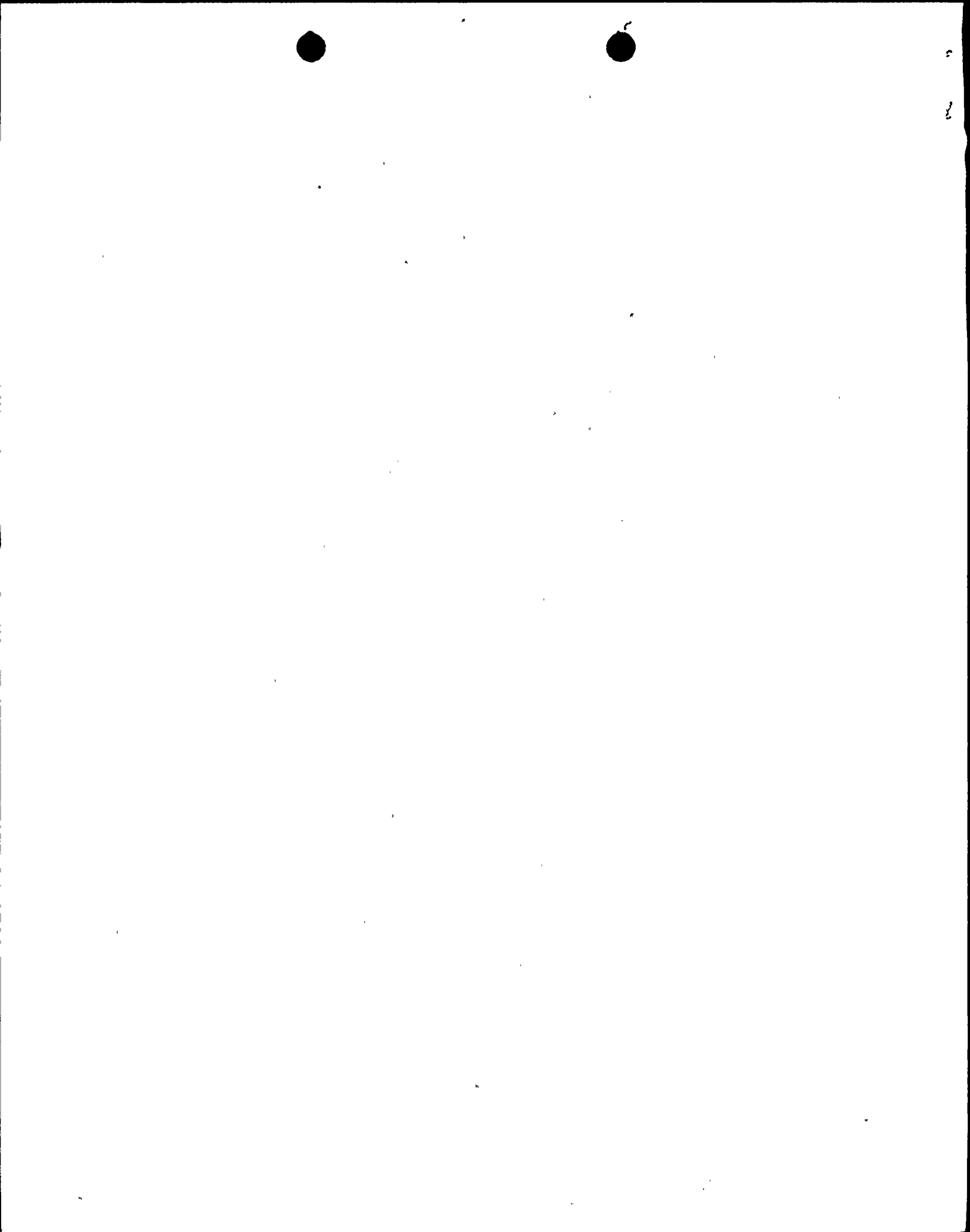
