Gentlemen:

In our letter of December 13, 1995 (NMP1L 1012), Niagara Mohawk Power Corporation (NMPC) informed the Nuclear Regulatory Commission (NRC) that the modification to replace existing Thermo-Lag fire barriers, as described in NMPC letter of December 14, 1994 (NMP1L 0884), was implemented on November 22, 1995. A review of our records indicates that the modification was only partially implemented on November 22, 1995. Full implementation of the modification was achieved on November 30, 1995.

The full implementation of this modification, N1-94-008, involving the replacement of Thermo-Lag 330-1 fire barriers with an acceptable material completes all Nine Mile Point Unit 1 actions related to TAC No. M85574 and Generic Letter 92-08.
