Subject: Generic Letter 96-01, Testing of Safety-Related Logic Circuits

Gentlemen:

The Commission issued Generic Letter (GL) No. 96-01, "Testing of Safety-Related Logic Circuits," to: 1) notify addressees about problems with testing of safety-related logic circuits, 2) request that all addressees implement the actions described in the GL, and 3) require that all addressees submit a written response to the GL regarding implementation of the requested actions. Required response No. 2 of the GL requested that licensees submit a written response confirming the completion of the requested actions. The purpose of this letter is to inform you that the requested actions have been completed.

In addition, Nine Mile Point Unit 2 Licensee Event Report 98-07 indicated that upon completion of the GL 96-01 review, a determination would be made as to whether the color-coded Logic System Functional Test drawings will become controlled documents or considered historical documentation. Niagara Mohawk Power Corporation has determined that these drawings will be considered historical documentation.

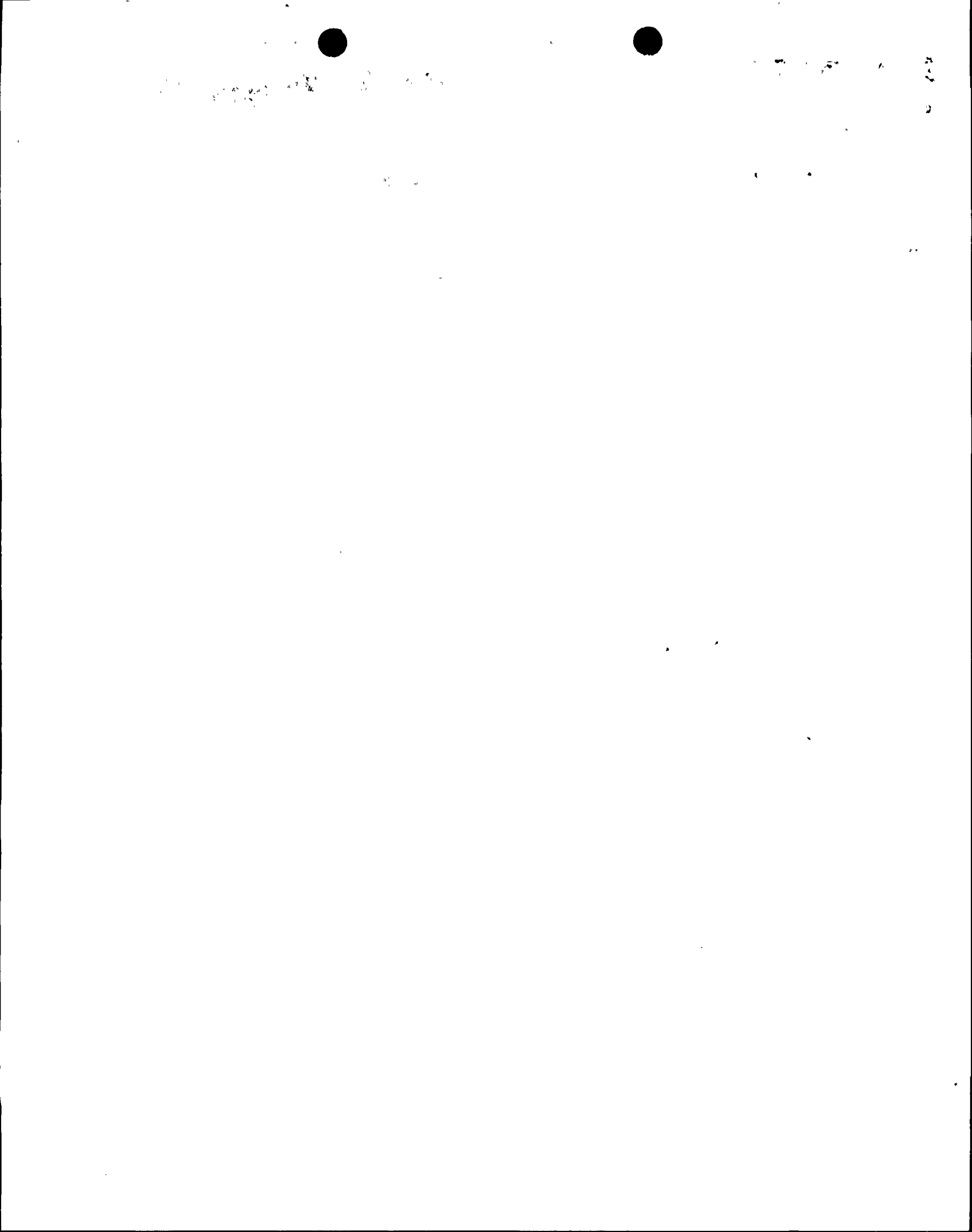
