Agency Response Dated February 13, 2017:	The IT environment contingency plan has been updated to include contingency procedures for the IT environment and other ITI managed components supporting the NRC remote locations including the TTC.
OIG Analysis:	OIG reviewed the updated contingency plan and determined that it was updated to include contingency procedures for the IT environment and other IT components supporting the one NRC remote location. This recommendation is therefore closed.

Recommendation 12: Update the COOPs for NRC remote locations that are referenced in Appendix G of the IT environment contingency plan to include current IT environment configurations at NRC remote locations and to address situations where the IT environment at those locations is unavailable for any reason.

Agency Response Dated  
February 13, 2017:

The references to COOPs for each of the NRC remote locations found in Appendix G of the ITI contingency plan have been replaced by a single regional COOP document.

The IT environment contingency plan has been updated to include current IT environment configurations at the NRC remote locations, including the TTC, and addresses situations where the IT environment at those locations is unavailable for any reason.

OIG Analysis:

OIG determined that the ITI Contingency Plan has been updated to include the current IT environment configurations at the NRC remote locations, and addresses situations where the IT environment at those locations might be unavailable for any reason. This recommendation is therefore closed.

#### Status of Recommendations

Recommendation 13: Develop a COOP for the IT environment and other IT components supporting the one NRC remote location that does not have a COOP.

Agency Response Dated  
February 13, 2017:

The references to COOPs for each of the NRC remote locations, including the TTC, found in Appendix G of the ITI contingency plan have been replaced by a single regional COOP document.

The IT environment contingency plan has been updated to include current IT environment configurations at the NRC remote locations, including the TTC, and addresses situations where the IT environment at those locations is unavailable for any reason.

OIG Analysis: OIG determined that the updated ITI Contingency Plan includes the current IT environment configurations at the NRC remote locations, and that the singular replacement COOP incorporates all NRC remote locations, including the TTC. This recommendation is therefore closed.
