Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, [ASTrainingandtravel.Resource@nrc.gov](mailto:ASTrainingandtravel.Resource@nrc.gov), no later than Friday, March 10. Individuals should request the Federal government rate at the hotels. The per diem for Houston, Texas is \$135 hotel and \$59 meals and incidentals. Rental cars are not reimbursable. If you are authorized to drive your personal vehicle, mileage reimbursement is 53.5 cents per mile.
