SUBJECT: SUMMARY OF FEBRUARY 9, 2017, CATEGORY II MEETING  
WITH STAKEHOLDERS TO SOLICIT INPUT ON THE DRAFT  
REGULATORY ISSUE SUMMARY ON CORRECTIONS AND  
REVISIONS TO CERTIFICATE OF COMPLIANCES (CAC NO.  
A33007)

Background. On February 9, 2017, a Category II meeting was held in Rockville, Maryland between representatives from the Nuclear Energy Institute (NEI), dry cask storage licensee and certificate holders, and the Nuclear Regulatory Commission (NRC) staff (staff) to solicit comments on the Draft Regulatory Issue Summary (RIS) on corrections and revisions to certificates of compliance (CoCs). The public was provided the opportunity to ask questions and provide comments during specific portions of the meeting. Regulatory decisions were neither requested nor made at the meeting. The list of meeting attendees is Enclosure 1. A detailed agenda of the meeting is Enclosure 2, and the presentation slides are provided as Enclosure 3.

Discussion. The discussion followed the agenda provided in Enclosure 2. The NRC staff provided a presentation on the Draft RIS on Corrections and Revisions to CoCs published for comment in the *Federal Register* January 18, 2017 (82 FR 5445). The first process presented is intended to make non-substantive corrections to CoCs and amendments and is called a "correction" process. This process is to be used for changes that are primarily editorial and administrative in nature and do not change the basis or regulatory evaluation of the CoC or amendment. The staff provided an example of an amendment "correction" that had recently been completed for HI-STORM 100, Amendment No. 8, as corrected on November 16, 2012 (ADAMS Accession No. ML12213A170). A revision process was then discussed which is intended to make minor technical changes or corrections to existing CoCs and amendments. General and specific examples were provided. Other details of the draft RIS such as backfitting and implementation times were also presented.

Industry stakeholders were then allowed to provide questions and comments on the presentation and the draft RIS. The NEI provided concerns about the implementation of the first amendment revision. The NEI also provided questions and comments about the NRC's backfit evaluation process when evaluating potential corrections and revisions. The NRC stated that the NEI and other stakeholders should provide their detailed comments or questions to the draft

RIS via formal comments on the published draft RIS by March 20, 2017. The NRC would then address and respond appropriately to each comment.

The public was then provided an opportunity to provide comments or questions. There were none provided.

The NRC thanked the NEI and industry stakeholders for their interest and participation and the meeting was adjourned.
